I HEREBY ACKNOWLEDGE, that I am aware that any weight in excess of that licensed to be carried in a hot air balloon is dangerous and I HEREBY DECLARE that my weight, as indicated above, is correct.

Hot Air Ballooning, because of the nature of the sport, is not conducted without some degree of risk. Existing and forecast weather conditions are very crucial to the flight and may result in a somewhat more difficult landing than anticipated. I HEREBY ACKNOWLEDGE that I am aware that there are risks associated with balloon flight (tether, free flight and crewing) operations, including without limitation, environmental hazards, weather conditions, equipment failure and judgment errors. Due to threats from the West Nile Virus in Ontario, I am aware that I am responsible for protecting myself by wearing appropriate clothing and insect repellent.

I understand that people with certain medical problems would be well advised not to consider a balloon flight and/or crewing. This would apply particularly to those who have had recent operations or broken bones or those who suffer from physical handicaps; back or spinal problems; hip, knee or joint replacements; heart condition; or those who may be pregnant. I further understand that it is my responsibility to advise the pilot prior to flight if I have any of these medical problems and I HEREBY DECLARE that I am in good health and fit to undertake a hot air balloon ride and/or crewings.

I HEREBY RELEASE "Skyward Balloons" and Graham Rawlinson and their servants, agents and employees, from any and all actions, causes' of actions, claims and demands of any nature, including, without limitation, all damages for personal injury, in connection with the balloon flights (both flying and/or crewing) operated by "Skyward Balloons" and Graham Rawlinson and/or their servants, agents or employees.

I HEREBY ACKNOWLEDGE, that neither "Skyward Balloons" nor Graham Rawlinson nor their servants, agents and/or employees, may be held responsible for lost or damaged articles of clothing, camera equipment, binoculars, etc. or any other personal belongings.

I HEREBY ACKNOWLEDGE that I have read and understood all material provided by "Skyward Balloons" and have read and understood the terms of this Agreement. This Agreement shall be valid from date of signature until and including December 31st, 2011 or until flight is completed.
